# WORKSHOP

### 2022 Winter School on Digital Cultural Tourism and Diplomacy

This event will focus on:

The 2022 edition of the USI UNESCO Chair Winter School will be realized in collaboration with the UNESCO Chair on Digital Cultural Heritage at the Cyprus University of Technology in Cyprus.

Indigenous cultural heritage is the legacy of tangible physical objects combining the intangible aspects of a group of society. Objects, artefacts, buildings, places and monuments aside, intangible cultural heritage, also known as "living heritage" or "living culture", refers to living practices, representations, expressions, knowledge, and skills passed down from generation to generation. This heritage provides communities with a sense of identity and is continuously recreated in response to their environment, their interaction with nature and their history. It is called intangible because its existence and recognition mainly depend on human knowledge and will, which is immaterial, and is transmitted by imitation and living experience.

The 2022 Winter School done as a collaboration between two UNESCO Chairs: "on Digital Cultural Heritage" and "in ICT to develop and promote sustainable tourism in World Heritage Sites", is dedicated to investigating how ICTs designed to enhance the tourism experience can help in preserving and transmitting living heritage and bring people to work and live closer together, while at the same time promoting different forms of tourism – cultural, historic, religious, eno-gastronomic, etc. – that go beyond traditional "sun sea and sand". Cyprus with its richness of tangible and intangible heritage will provide a suggestive background, as well as an ideal environment with various case studies.

Lectures and talks, visits to UNESCO World Heritage Sites and other places, experience of unique local traditions, hands-on exercises, and a range of formal and informal activities will allow participants to understand how to leverage smart digital technologies for sustainable tourism and cultural diplomacy in order to preserve and transmit living heritage.

A certificate of participation that will include the detailed program and list of speakers will be issued at the end of the Winter School. ECTS credits are not granted, but academic institutions may recognize ECTS credits upon presentation of this certificate.

Minister of Transport, Communications and Works of the Republic of Cyprus

Yiannis Karousos is a Cypriot politician and current Minister of Transport, Communications and Works of the Republic of Cyprus. Yiannis Karousos was born on 21 November 1979 in Ayia Napa. He holds a BSc (Hons) in International Hospitality and Tourism Management from the University of Surrey, UK, where he specialized in strategic development of tourist destinations. Additionally, he holds an MBA (Joint) from the French ESSEC Business School and Cornell University, USA. He has also been awarded the tittle of Chartered Marketer from the UK Chartered Institute of Marketing.

Prior to his appointment as a Minister of Transport, Communications and Works on December 3, 2019, he served as the Mayor of Ayia Napa (2013 - 2019) and as Municipal Councilor of Ayia Napa (2006 - 2013).

He also assumed the positions of the President of the Famagusta Province Tourism Development and Promotion Society, the President of the Ayia Napa Sewerage Board and the President of the Ayia Napa - Paralimni Sewerage Board Consortium. He was the founder and President of the Youth Council of Ayia Napa, he served as Chairman of the Tourism Committee and as a member of the Cultural Committee of Ayia Napa Municipality. Additionally, he was a member of the Board of the Charitable Foundation 'Despina', which supports children with diabetes.

PRESENTATION TITLE: CYPRUS' CULTURAL HERITAGE GOING DIGITAL: LESSONS LEARNT FROM THE PANDEMIC

**ABSTRACT:** Over the last two years, the COVID-19 pandemic led us to explore new ways to promote the cultural heritage of Cyprus to the public and especially to tourists, offering them a more interesting and unique cultural experience. The management of the cultural heritage of Cyprus is a multidimensional target with a vast amount of data and information to be handled. We strongly believe that we can successfully achieve our goal with the help of the tools provided to us by digital technology.

Savvas Perdios is the Deputy Minister of Tourism of the Republic of Cyprus as of 2 January 2019. Savvas Perdios was born on 1981 in Lefkosia. He studied Accounting and Finance at Warwick University (2002-2004) and International Hospitality Management (BA, 2004-2008) at the École hôtelière de Lausanne.

His career in hospitality began at the very young age of 15, undertaking various summer jobs in hotel departments like kitchen, maintenance, service, banqueting, housekeeping and guest relations. Between 2008 and 2010 after completing his studies, Mr Perdios worked for internationally-known companies like Design Hotels in Mykonos and Kempinski Hotels

in Switzerland. From January 2010 until January 2018 he worked at Louis Hotels in the position of Quality and Brand Manager. This entailed being in charge of creating, implementing and maintaining operating standards across the whole portfolio (25 hotels and several restaurants), and also being in charge of branding and reputation management. After eight years in this position, Mr. Perdios was promoted to Chief Operating Officer, a position which he held until his appointment at the Cyprus Deputy Ministry of Tourism.

#### PRESENTATION TITLE: SAFEGUARDING THE TOURISM SECTOR THROUGH THE PROVISION OF AUTHENTIC EXPERIENCES

**ABSTRACT:** The Cyprus Government acknowledged that the long-term absence of a national strategy for the sustainable development of the rural and mountainous communities has resulted in desertion, decline of the production output and entrepreneurship initiatives. These negative developments had devastating effects on the economic, social and cultural life in these communities. For this reason, the Government prepared a "Comprehensive Development Policy for the Mountainous areas of Cyprus" and set its implementation as a priority.

The Deputy Ministry of Tourism, studying ways to contribute to the implementation of the objectives of this Policy, acknowledged that the mountainous areas have to offer many authentic experiences that enrich the Cyprus tourism product. The development, utilization and targeted promotion of these experiences can attract specific segments of the tourism market, so that the mountain communities can benefit from tourism. Consequently, the tourism development in mountainous and remote areas is one of the priority goals of the 2030 Tourism Strategy.

Kyriakos Hadjiyiannis is a chairperson of the House Standing committee on energy, trade, industry and tourism of the Republic of Cyprus. Kyriakos Hadjiyiannis was born on 1963; his place of origin is Acheritou and Agios Sergios. He studied Mechanical Engineering, Economics and Political Science at Universität Stuttgart, Germany and obtained his doctorate (PhD) in Political Science at Universität Tübingen, Germany.

He is representative of Famagusta constituency under the banner of DISY since 2006. He is currently a member of the House Standing Committee on Agriculture and Natural Resources and a member of the delegation of the House to the OSCE PA. He previously served as a Chairperson of the House Standing Committee on Educational Affairs and Culture, a Chairperson of the Democracy, Human Rights and Humanitarian Questions Committee of the Parliamentary Assembly of the Organisation for Security and Co-operation in Europe (OSCE PA) and a member of the Bureau of the OSCE PA.

He was the Secretary of the DISY Youth Organisation (NEDISY) Enlightenment Committee and Famagusta District Secretary of the Organisation of Young Scientists (ONE). Between 2003 and 2004 he served as an Observer Member at the Economic and Social Council of the European Union. He was the General Secretary of the "Panagrotikos" (Cyprus' Farmers Association) until 2008. He served as the Vice Chairperson of the European Syndicate of Farming Organisations (COPA) and member of several advisory committees of the General Directorate of Agriculture and Rural Development of the European Union. He was a Vice Chairperson of the European People's Party group to OSCE PA and a member of the "Junge Union" youth organisation of the Christian Democratic Union (CDU) in Stuttgart, Germany.

Pierre-Yves Fux is Swiss Ambassador to the Republic of Cyprus (since 2018). He previously served as Ambassador to the Holy See. He studied and taught at the University of Geneva, where he defended a thesis on the poet Prudence entitled Les sept passions de Prudence. In 2013 he published the commentary on the other poems of the Peristephanon, and is the author of other articles and texts in the field of antiquity, in particular on Christian writers. In addition to his doctorate in letters, he holds a DEA from the École Pratique des Hautes Etudes , 4th section, "Methods of History and Archaeology"; 1992), a postgraduate diploma from theScuola vaticana di paleografia greca (1995) and a DES in philosophy from the University of Geneva (Medieval metaphysics in the Jewish, Islamic and Christian context , 1995). He was a member of the Swiss Institute in Rome (1995). In 1996, he entered the Swiss diplomatic service. In addition to positions at the Federal Department of Foreign Affairs (FDFA: 1998-2001, 2007-2013), he held positions in Tel Aviv (1997-1998), Tokyo (2002-2005), Tehran (2005-2007) and Amman (2014). He has published articles on Israel and the Israeli-Palestinian conflict.

He was Ambassador to Slovenia (2014-2018), during which time he hosted the bilateral visits of the President of the Confederation Simonetta Sommaruga (2016) and the Federal Councilor (Minister of Foreign Affairs) Didier Burkhalter (2017), and accompanied the visit to Switzerland of the President of the Republic Borut Pahor (June 20, 2018).

He supports and practices the Latin language, including as a spoken language. In 2018, he gave a lecture in Latin at the Pontifical Salesian University on the invention of the web at CERN and he announced in this language the visit of Pope Francis to Geneva in an interview with Télévision suisse romande (RTS).

During his mandate at the Holy See (2014-2018), he hosted the visits of Federal Councilor Alain Berset (2015), Presidents of the Confederation Johann Schneider-Ammann (2016) Doris Leuthard (2017) and Alain Berset (2018). He organized and accompanied the visit of Pope Francis to Geneva on June 21, 2018.

He kept his mandate near the Holy See until November 2018, while assuming that of Ambassador to the Republic of Cyprus, from the spring of that same year.

#### PRESENTATION TITLE: A FRAMEWORK TO UNDERSTAND THE ROLE OF ICTS FOR SUSTAINABLE TOURISM AT HERITAGE SITES

**ABSTRACT:** In the last two decades Information and Communication Technologies (ICTs) have played a major role not only in the restauration sector, but also to promote and support visits and touristic activities. This has become particularly relevant due to the diffusion of smart phones, and the consequent experience and expectation of being 'always on'. Heritage and cultural destinations can definitely benefit from ICTs, providing a range of relevant services and experiences, which can increase access to information by interested people, improve their experience once at the destination, better connect both residents and visitors to the heritage, dis-intermediate some relationships, and educate relevant stakeholders. The presentation introduces a framework to understand the role of ICTs for sustainable tourism at heritage sites, discussing some good practices.

The office also carries out architectural design of museums, buildings and complexes, buildings of special use, interventions – preservations of historic and listed buildings, reconstructions and upgrades of protected and preserved totals and historical settlements, urban environmental planning and landscape, landscaping.

He has served as Assistant professor at the History Department of the Venice University Institute of Architecture. He has either organized, co-ordinated, participated in, delivered talks/lectures in cultural events, architecture exhibitions, conferences and workshops. **ABSTRACT**: Cultural Tourism (CT) plays a crucial role in today's economies, representing about 37% of the total tourism sector, with an annual growth of around 15%. This role and impact on the economy can be capitalized by certain regions and sites of EU and beyond having a high cultural, social and environmental potential. This impact does not only depend exclusively on the existence of historical-picturesque heritage, but is also related to other synergistic factors such as know-how, ICTs, gastronomy, identity, local culture, values, intangible heritage or other singularities. TExTOUR mobilizes 18 partners, represented in the quintuple social innovation helix (knowledge, business, society, government and entrepreneurs) to co-design, validate and upscale to various levels, policies and strategies with positive impact on the socio-economic territorial development based on cultural tourism.

TExTOUR uses ICTs and social innovation tools to work with 8 Cultural Tourism Pilots in less known areas to conceive and design collaborative work methodologies for the development of CT strategies for their sites. Each pilot sets up Labs Communities, composed of a wide range of stakeholders with a relevant role in the development of CT sector. The stakeholders are guided through the Cultural Tourism-Labs for the implementation, monitoring and validation of the CT ad hoc strategies. The project develops procedures services and tools and carries out activities, proposed in the methodology. Their results are used to prepare a modular and scalable EU Action Plan for Cultural Tourism Development. In parallel, a technological platform is designed and tested to assess CT policies and strategies envisaged by public and private stakeholders. It provides data analytics as a service, together with a catalogue of relevant services representing the assessed CT strategies, and proper content curation and validation processes, apart from assessing the implemented practices and its related impacts.

Although TEXTOUR recently started from January 2021 the project can be explained and the experience of its implementation during several months can be shared at the end of October 2021 when the conference will take place.

#### PRESENTATION TITLE: TOWARDS MORE SUSTAINABLE FORMS OF CULTURAL TOURISM. CAN ICTS OFFER HELP?

**ABSTRACT:** Over the past few decades, tourism has grown to become one of the principal cornerstones of the global economy as well as part of the economic base of almost all cities in the world. The COVID-19 pandemic has not only shown how fundamental tourism is for the global economy, but also how vulnerable the tourism system is to disruptive events. This is especially true for cities that were hit particularly hard by the COVID-19 crisis. But sooner rather than later, tourism will recover and an adequate and innovative strategy – which is able to help urban destinations to recover, to consolidate and to flourish again – ought to be in place.

#### PRESENTATION TITLE: RURITAGE - REGENERATING RURAL AREAS THROUGH HERITAGE-BASED STRATEGIES

ABSTRACT: European rural areas embody outstanding examples of Cultural and Natural Heritage (CNH) that need not only to be safeguarded, but also promoted as a driver for competitiveness, sustainable and inclusive growth and development. RURITAGE establishes a new heritage-led rural regeneration paradigm able to turn rural areas in sustainable development demonstration laboratories, through the enhancement of their unique CNH potential. RURITAGE has identified 6 Systemic Innovation Areas (pilgrimages; sustainable local food production; migration; art and festivals; resilience; and integrated landscape management) which, integrated with cross-cutting themes, showcase heritage potential as a powerful engine for economic, social and environmental development of rural areas. The knowledge built in 19 Role Models (RMs) and digested within the project, has been transferred to 6 Replicators (Rs) across Europe and it is now available within the RURITAGE Resources Ecosystem. Through a multilevel and multidirectional process of knowledge transfer, RMs mentored and supported the Replicators in the development and implementation of their strategies and, at the same time, have further increased their knowledge and capacities. Local Rural Heritage Hubs, gathering stakeholders and civil society, have been settled in all Rs and RMs to work as living labs where heritage-led rural regeneration strategies have been co-created and are now implemented. Working on the six identified Systemic Innovation Areas, many Rs and RMS have developed actions touching upon sustainable cultural tourism, including among others the development of new hiking routes or the restoration of existing ones, the development of tourism package built together with local stakeholders where art, gastronomy and local artefacts and the development of art, music, dance and poetry Festival and exhibition. The presentation will touch upon these and many other aspects, giving an overview of RURITAGE methods, tolls and main outcomes achieved so far.

**ABSTRACT:** The INCULTUM project deals with the **challenges and opportunities of cultural tourism** with the aim of furthering sustainable social, cultural and economic development. It explores the full potential of **marginal and peripheral areas** when managed by local communities and stakeholders. Innovative **participatory approaches** are adopted, transforming locals into protagonists, able to reduce negative impacts, learning from and improving good practices to be replicated and translated into strategies and policies.

Furthermore, INCULTUM fosters **intercultural understanding** through the implementation of bottom-up strategies that can have positive effects for both, locals and tourists. Ten pilot **cases of living territories and communities** are investigated and on the basis of the findings innovative customised solutions will be co-created.

PRESENTATION TITLE: SPOT PROJECT - SOCIAL AND INNOVATIVE PLATFORM OF CULTURAL TOURISM AND ITS POTENTIAL FOR DEEPENING EUROPEANIZATION

**ABSTRACT:** Cultural tourism is one of the rapidly developing parts of the tourism sector. We define it as tourism, which is associated with knowing other regions, travelling for experiences to places and for activities that capture the stories of the past and present. It may relate to natural beauties, inhabitants and their customs and traditions, historical and cultural heritage or cultural events. Likewise, locals and entrepreneurs get to know the culture of visitors. It is therefore a pity that cultural tourism is considered almost exclusively as an economic sector (at least in Czechia) and not as part of the culture. Mendel University in Brno is the coordinator of a consortium consisting of institutions from 15 countries under the Horizon 2020 project "Social and Innovative Platform of Cultural Tourism and its Potential for Deepening Europeanization" for the period 2020-2022. The project is focused on the analysis of national policies in the tourism sector, covering case studies in 15 countries and the development of a new innovative SPOT-IT tool, which should help actors in the public and private spheres in the management of cultural tourism. The project coincides with the onset of the COVID-19 pandemic, which has affected tourism the most of all sectors. The results for the first two years include, among other things, a critical analysis of the existing state of the art, including available scientific sources and policy documents in the tourism sector, the results of a sociological survey on the perception of the development of cultural tourism among tourists, entrepreneurs and residents, many internationally comparable examples of good practice and a beta version of the innovative SPOT-IT tool.

**ABSTRACT:** Many destinations have been dealing with the sustainability and resiliency challenges posed by the global pandemic. Prior to the advent of COVID-19, these same venues were dealing with issues stemming from overtourism, environmental stress, inappropriate visitor behaviour and economic leakage. As tourism begins to recover, a key document, the DRAFT ICOMOS International Cultural Tourism Charter, represents an opportunity to rethink and rejuvenate cultural tourism at individual destinations. Through its objectives and principles, this includes addressing short- to medium-term matters such as pandemics, conflicts and national disasters and longer term concerns like climate change.

**Kyriakos Efstathiou**, a Cypriot citizen, is the holder of the ERA Chair on Digital Cultural Heritage, Cyprus University of Technology. Kyriakos holds a PhD Degree from the Department of Mechanical Engineering at the Aristotle University, Thessaloniki (Greece) and was for 37 years a researcher and Professor there, serving as Director of the Laboratory for Machine Tools and Manufacturing Engineering, and Director of the Design and Construction Department. He was the Leader of the Aristotle University research team, which investigated the Antikythera Mechanism, the first analogue computer in the human history. #### PRESENTATION TITLE: THE CHALLENGES OF DCH ON CULTURAL TOURISM AND CULTURAL DIPLOMACY: GROWTH AND RISKS?

**ABSTRACT:** Cultural heritage objects have been constantly undergoing changes and degradations over time, due to environmental conditions, destruction by human intervention and conservation treatments. Changes and degradations may also result from accidents. Recent examples are the catastrophic fires at Notre-Dame of Paris and at the National Museum of Brazil. To preserve the knowledge of the past, all the CH monuments sites and objects should be protected with the greatest safety measures from environmental and human interventions and must be thoroughly studied and recorded holistically through digitization (tangible and intangible). There is an urgent need for massive digitization of the various monuments and sites, as well as of objects in the museums of Europe and all over the word. Thus, we must address the current technical, administrative, and legal barriers. The main objective of the ERA Chair project MNEMOSYNE in Digital Cultural Heritage is the holistic documentation of the Digital Cultural Heritage lifecycle, including both the tangible and the intangible aspects of Cultural Heritage assets. Besides the benefits of CH digitization in the preservation and restoration of CH objects, it can also be a very powerful tool in promoting tangible heritage and transmitting intangible heritage. Using smart digital technologies (e.g. Immersive VR and AR applications) can aid in the promotion of heritage sites and living culture and the development of sustainable cultural tourism.

#### THE CITY OF LIMASSOL

The city of celebrations since ancient times, Lemesos (Limassol) continues its status as the festive center of the island to this day and is vibrant and lively, yet also provides all the elements for a relaxing beach break, or an unhurried expedition of historical discovery. From the wedding of Richard the Lionheart and the feasts in honor of ancient deities, to today's carnival celebrations and Wine Festival, Lemesos has always attracted visitors in their flocks for its exciting events and social reveling.



Its position between two large city-kingdoms of ancient

times - Amathous and Kourion - has blessed the area with a significant archaeological status, whilst the town in between is modern and diverse with a range of coastal strips, shopping options, drinking, dining and entertainment. And Lemesos has the added bonus of being the island's maritime capital, thanks to its main



commercial and business port, and the exclusive, modern marina where both residents and visitors alike can enjoy sea views at one of the many waterfront establishments.

As its rural areas stretch upwards to the mountains, some of the island's main winemaking villages can be found, giving the Lemesos region its unique link with the age-old tradition of viticulture.

#### **MEDIEVAL CASTLE OF LIMASSOL**

Lemesos (Limassol) Medieval Castle is situated in the heart of the old town, just above the old harbour. According to tradition, this is where Richard the Lionheart married Berengaria of Navarre and crowned her Queen of England in 1191. The fortified walls are of considerable archaeological interest and thought to be fragments of a much larger castle.

The exact date of the fort's construction is not known; according to Etienne de Lusignan, it was built in 1193 by the founder of the Lusignan dynasty, Guy de Lusignan, but the first official reference to the fort dates to 1228, during the involvement of Frederic II of Germany in the affairs of Cyprus. Throughout the years, the

fort suffered the assaults of many invaders, sustaining further damage in the earthquakes of 1567 and 1568. Finally, in 1590, the Ottomans rebuilt the fort in its current form.

The original fort was larger than the later one, which incorporates some parts of the former building, such as the two oblong halls of the ground floor. Below the eastern hall there is a basement with cells, which was used as a prison until 1950. Today, the fort houses the Medieval Museum of Cyprus.

#### THE CYPRUS WINE MUSEUM

Cyprus was one of the first countries in the world to make wine and it has a history of winemaking that stretches back more than 5500 years, that is interwoven with many of the events and traditions of the island. Historians believe that Cyprus has the longest continuous history of winemaking in the world.



The museum displays the history of Cyprus wine, the science of Cypriot wine making and

the diversity of the Cyprus wine industry all under the same roof. The Cyprus Wine Museum is located near by the chalcolithic settlement of Erimi, where fragments of pottery belonging to 18 pointed base flasks were found. The large amount of tartaric acid found in the Flasks proves that wine has been produced on the island for over 5500 years. This makes Cyprus the home of the oldest wine in Europe. Erimi village, at the crossroads of the wine routes of Cyprus, is near by Limassol in close proximity to the prehistoric settlement of Sotira, where the oldest remains of grape seeds have been found and also near to Kolossi Castle, a medieval Commanderie of the Hospitaller Knights that gave the name to the Commandaria Wine.

The Cyprus Wine Museum is housed in a beautifully renovated two-storey stone building that has been owned by the family of Cypriot composer Anastasia Guy for more than a century. On the first floor of the building is the Wine Museum which gives an innovative and creative insight into the history of winemaking in Cyprus. It is divided in four main chronological periods. The Ancient, the Byzantium, the Medieval and the Modern period of winemaking.

On the same floor visitors can enjoy an audiovisual journey of winemaking through the centuries.

In St Ilarion Hall, on the ground floor of the museum, we exhibit the Wine Trails. Here we show in a series of alcoves in the stone walls the Cypriot wine producers. It is here that visitors can relax and enjoy some of the different indigenous varieties of wines, accompanied by traditional Cypriot delicacies. Seminars about the methods of wine tasting, the history of Cypriot wine and in general the wine tradition of the island are held in the St Ilarion Hall.

Visitors can wander out into the traditional eastern courtyard where there is a display of traditional equipment that includes the stone pits (patistra) where the grapes were crushed, the distillation equipment used for making the traditional spirit Zivania and a number of pitharia - the red clay jars in which the wine was fermented and stored.

Outside in the western courtyard there is an attractive small open air stone theatre that is the setting for regular musical soirees and other cultural events.

Also here is the perfect setting for private parties such as Ancient Greek, Roman, Medieval nights etc. The ideal place for exhibitions, conferences, seminars, wedding ceremonies and events.

The Cyprus Wine Museum it is placed at the starting point of the 'Wine Routes of Cyprus' and is also suggested to be visited in the 4th route and 5th route. The "Krasochoria Lemesou" (Wine Villages of Limassol) and "Commandaria" route.

#### THE CITY OF PAPHOS

Legends of love, magnificent mosaics, archaeological awes and captivating coasts make the small town of Paphos enlightening to explore, and beautiful to behold. Paphos was originally the island's capital some centuries ago, but can now instead call itself the capital of culture, thanks to its significant historical sites and monuments - many of which are linked to the Ancient Greek Goddess of Love and Beauty - Aphrodite.



It is no wonder then that due to its sheer wealth of ancient remnants, Kato Paphos as a whole has been declared a UNESCO World Heritage Site. Paphos is comprised of its old and new towns, with its harbour and Medieval Castle

forming the focal point. The region also has quaint resorts further afield, including that of Polis Chrysochou and its fishing port of Latchi, and is home to areas of stunning natural splendour, including the Akamas Peninsula and its Avakas Gorge, Lara beach (where Green Turtles nest), and Petra tou Romiou (Aphrodite's Rock/ birthplace).

Although small in size, Paphos is big on the experiences it offers. The region is proud for its timeless heritage etched within the plentiful archaeological sites and enthralling museums. Paphos is the land of saints, painted churches, legends and miracle-working icons. Nowhere else can you see every style of Byzantine art in such a small area. Paphos is one of the most important centers of ancient civilization in the Mediterranean. Once the ancient capital of Cyprus, it is undeniably one of the most fascinating locations in Europe that has cemented its name in the cultural tourism industry.

#### PETRA TOU ROMIOU/BIRTHPLACE OF APHRODITE

Aphrodite's mythical birthplace 'Petra tou Romiou' is an interesting geological formation of huge rocks along one of the most beautiful coastlines on the island, located on the southwest coast of the Paphos (Paphos) district.

According to the legend, the Ancient Greek Goddess of Love and Beauty - Aphrodite - was born of the sea foam here. Legend tells that she rose from the waves and was escorted on a shell to this particular beach.



The giant rock formations, which are seen at the same location are linked with another - more recent legend which tells that the Byzantine hero Digenis Akritas heaved them there to keep the Saracens Arabs (7th-10th centuries) at bay. The name of Petra tou Romiou ('rock of the Greek' in Greek) comes from the hero.

It is said that in certain weather conditions, the waves rise, break and form a column of water that dissolves into a pillar of foam. With imagination, this momentarily looks like an ephemeral, evanescent human shape. Other popular myths tell that swimming around the rock three times will bring various blessings, including eternal youth and beauty, good luck, fertility and true love.

#### PAPHOS ARCHAEOLOGICAL PARK


The Archaeological Park of Kato Paphos is one of the most important archaeological sites of Cyprus and has been included in the UNESCO World Heritage Sites list since 1980.

Nicocles, the last King of Palaipaphos moved the city from the previous location to its present location near the harbor at the end of the 4th century BC. Between the 2nd century BC and 4th century AD, Pafos was the capital city of Cyprus.

The Park includes sites and monuments from the 4th century BC to the Middle Ages, while most remains date to the Roman period. The intricate mosaic floors of four Roman villas (the houses of Dionysos, Theseus, Aion and Orpheus) form the impressive epicenter of the finds, and depict various scenes from Greek Mythology. The complex also includes other important monuments, such as the Asklepieion, the Odeon, the Agora, the Saranta Kolones (Forty Columns) Castle, the Limeniotissa ruins of an Early Christian Basilica, and the Tombs of the Kings.

#### **MEDIEVAL CASTLE OF PAPHOS**

Standing grandly at the west end of the town's harbour, Pafos (Paphos) Castle (Medieval Fort) was originally a Byzantine fort built to protect the harbour, and was rebuilt by the Lusignans in the 13th century, but then dismantled by the Venetians.

The Ottomans rebuilt it in the 16th century when they conquered the island. What survives today is the 1592 Ottoman restoration of the western Frankish tower with its Venetian additions. An inscription above the only entrance of the castle bears witness to this restoration.



The main part of the castle is a big square tower that has an enclosed courtyard in the middle. The ground floor consists of a central hall with small rooms on each of its two long sides, which were used as prison cells during Ottoman Rule. There are 12 battlements on the roof, which received a corresponding number of cannons.

The Ottomans removed the cannons in 1878, when they handed over the administration of the island to the British, who used the castle as a salt store until 1935, when it was declared an Ancient Monument under the Antiquities Law.

#### **CHRYSOROGIATISSA MONASTERY**

Set in beautiful natural surroundings, the Monastery of Chrysorogiatissa is dedicated to 'Our Lady of the Golden Pomegranate' and was established in 1152 by monk Ignatios. Legend tells that the monk found a miraculous icon of the Virgin Mary off the shore of Pafos (Paphos). The icon had been thrown into the sea in Asia Minor during the iconoclastic period and drifted to Pafos on the waves. The present structure - a single-aisle church built on the foundations of an older one - dates to 1770.

Fine frescoes are found above the three entrances, whilst a gold and silver-plated icon of Christ and the Virgin Mary in the monastery is believed to have been painted by Apostle Luke the Evangelist. The Icons and Utensil Treasury of the monastery is also home to a collection of important icons, religious objects and other artefacts. The occasion of the Dormition of the Mother of God is celebrated at the monastery every August 15 with a grand religious ceremony, whilst the monastery's old winery produces some of the best vintage wines on the island.
